



## STIs & YOUNG ADULTS


While sexually transmitted diseases (STDs) affect individuals of all ages, STDs take a particularly heavy toll on young people.

CDC estimates that youth ages 15-24 make up just over one quarter of the sexually active population, but account for half of the 20 million new sexually transmitted infections that occur in the United States each year.
















### Human Trafficking

Recruiting, enticing, harboring, transporting, providing, or obtaining by any means another person with the intent that the other person be held in involuntary servitude or sexual servitude or causing a minor to be held in involuntary servitude or sexual servitude.

-- NCGS 14-43.11

Servitude: conduct induced by coercion or deception




















# Impact/Ripple Effect of Sexual Assault and Violence

- 95% of Human Trafficking Victims were sexually assaulted as children
- Sexual assault victims have a higher risk of engaging in drug use
- Adverse Childhood Experiences increase the risk for risky health behaviors, poor mental health and chronic conditions
- Local system changes: those that come with suicidal ideation are automatically screened for sexual abuse
- Counseling and access to services: Medicaid covered, state will reimburse parents for counseling if privately insured.
- All victims of sexual abuse should have access to services
  Not enough qualified trauma informed counselors (victims and offenders)
